POSITION SUMMARY

The Aging in Place Specialist is a full-time position responsible for the client management and coordination of resources for older adults aged 60 and above who reside in Wayne County, PA. In conjunction with the Aging in Place Coordinator and Occupational Therapist, the Wayne County Specialist will provide direct services to aging homeowners with the goal of assisting seniors to age in place safely and with dignity.

PRIMARY RESPONSIBILITIES

- Work closely with Wayne County Area Agency on Aging staff and Intake Coordinator to identify and manage referrals from Wayne County Area Agency on Aging.
- Conduct intakes and in home assessments to determine the modification and community needs to improve the quality of life of older homeowners.
- Work in a team environment with Occupational Therapist and Aging in Place Coordinator to make appropriate recommendations regarding the assistance needed for each homeowner.
- Coordinate appropriate referrals and serve as an advocate for outside services related to assisting homeowners age safely and with dignity in their homes.
- Aid older homeowners in applying for benefits and resources that may make their homes safer and more affordable.
- Provide application and document retrieval assistance to older homeowners in applying for benefits and resources that may make their homes safer and more affordable.
- Provide resource connection to older homeowners to ensure they are residing safely and with dignity in their homes.
- Attend meetings as assigned by NeighborWorks Northeastern Pennsylvania.
- Maintain clear and concise records, including timely data entry in data management system.
- Work with Aging in Place Coordinator on reporting, meeting coordination, grant-seeking and administration, and other tasks.
- Maintain connections with other social service organizations to ensure the most up to date resources are provided and referrals are followed up on in a timely manner.
- Conduct follow up calls to and for older adults requesting information regarding NeighborWorks Northeastern Pennsylvania Aging in Place services.
